This Amendment Number 2 to **Contract** Number **DIR-TSO-3343** (“**Contract**”) is between the Department of Information Resources (“**DIR**”) and JourneyEd.com Inc. (“**Vendor**”). DIR and Vendor agree to modify the terms and conditions of the **Contract** as follows:

1. **Contract, Section 2. Term of Contract** is hereby amended as follows:

DIR and Vendor hereby agree to extend the term of the Contract for one (1) year through October 1, 2018, or until terminated pursuant to the termination clauses contained in the Contract. The contract will renew automatically in one -year increments for one (1) additional year under the same terms and conditions unless either party provides notice to the other party 60 days in advance of the renewal date stating that the party wishes to discuss modification of terms or not renew.
