This Amendment Number 2 to Contract Number DIR-TSO-3488 ("Contract") is between the Department of Information Resources ("DIR") and Red River Consulting Services LLC formerly Ambonare Incorporated ("Vendor"). DIR and Red River Consulting Services, LLC agree to modify the terms and conditions of the Contract as follows:
