This Amendment Number 1 to **Contract** Number **DIR-TSO-3740** ("**Contract**") is between the Department of Information Resources ("**DIR**") and Avid Systems, LLC ("**Vendor**"). DIR and Vendor agree to modify the terms and conditions of the **Contract** as follows:

1. **Contract, Section 2. Term of Contract**, is hereby redacted in its entirety and replaced with:

The term of this Contract shall be one (1) years commencing on the last date of approval by DIR and Vendor. DIR and Vendor hereby agree to extend the term of the Contract for one (1) year through February 12, 2019 or until terminated pursuant to the termination clauses contained in the Contract. Prior to expiration of the term, the contract will renew automatically in one-year increments for two additional years under the same terms and conditions unless either party provides notice to the other party 60 days in advance of the renewal date stating that the party wishes to discuss modification of terms or not renew.

Additionally, the parties by mutual agreement may extend the term for up to ninety (90) additional calendar days.

2. **Appendix A, Standard Terms and Conditions for Products and Related Services Contracts**, is hereby restated in its entirety and replaced with the attached **Appendix A, Standard Terms and Conditions for Services Contracts dated 09/29/2017**.
