This Amendment Number 1 to **Contract** Number **DIR-TSO-3839** ("**Contract**") is between the Department of Information Resources ("**DIR**") and Mission Critical Partners, LLC., formerly Mission Critical Partners, Inc. ("**Vendor**"). DIR and Vendor agree to modify the terms and conditions of the **Contract** as follows:

1. DIR acknowledges the name change of the Vendor to Mission Critical Partners, LLC. from Mission Critical Partners, Inc. with its principal place of business at 690 Gray's Woods Blvd, Port Matilda, Pennsylvania 16870. The effective date of change is January 2, 2018. DIR shall change the contract documents hereafter to Mission Critical Partners, LLC.
2. Mission Critical Partners, LLC. hereby agrees to perform all duties and obligations to be performed by Vendor under Contract DIR-TSO-3839 to the same extent as if it had been an original party thereto.
3. Mission Critical Partners, LLC. also represents that it is not currently delinquent in the payment of any franchise tax owed the State of Texas and is not ineligible to receive payment under §231.006 of the Texas Family Code and acknowledges the Contract may be terminated and payment withheld if this certification is inaccurate.
4. Mission Critical Partners, LLC. hereby represents it is authorized to do business in the State of Texas and is in good standing with the Comptroller of Public Accounts.
5. **Contract, Section 2. Term of Contract**, is hereby amended as follows:
The term of this Contract shall be two (2) years commencing on the last date of approval by DIR and Vendor. Prior to expiration of the original term, the contract will renew automatically in one-year increments for two additional years under the same terms and conditions unless either party provides notice to the other party 60 days in advance of the renewal date stating that the party wishes to discuss modification of terms or not renew. Additionally, the parties by mutual agreement may extend the term for up to ninety (90) additional calendar days.
6. **Appendix A, Standard Terms and Conditions for Deliverables-Based Information Technology (DBITS) Services Contracts dated 02/4/2017**, is hereby replaced in its entirety with **Appendix A, Standard Terms and Conditions for DBITS Services Contracts dated 01/08/2018**, as attached.

All other terms and conditions of the Contract not specifically modified herein shall remain in full force and effect. In the event of a conflict among provisions, the order of precedence shall be this Amendment Number 1 and then the Contract.
