This Amendment Number 4 to Contract Number DIR-TSO-3992 ("Contract") is between the State of Texas, acting by and through the Department of Information Resources ("DIR") and BKTB Group, Inc. dba MC Austin, formerly known as BKTB Group, Inc. dba Mercury Communications of Austin ("Vendor"). DIR and Vendor agree to modify the terms and conditions of the Contract as follows:

1. Contract, Section 1. Introduction is hereby amended as follows.

A. Replace Section A. Parties in entirety as follows.

A. Parties

This Contract for services is entered into between the State of Texas, acting by and through the Department of Information Resources (hereinafter "DIR") with its principal place of business at 300 West 15th Street, Suite 1300, Austin, Texas 78701, and BKTB Group, Inc. dba MC Austin, formerly known as BKTB Group, Inc. dba Mercury Communications of Austin (hereinafter "Vendor"), with its principal place of business at 7801 North Lamar, Suite A-123, Austin, TX 78752.

DIR acknowledges the name change from BKTB Group, Inc. dba Mercury Communications of Austin to BKTB Group, Inc. dba MC Austin, with its principal place of business at 7801 N. Lamar, Suite A-123 Austin, TX 78752.

This change is effective as of the Effective date of this Amendment Number 4. DIR agrees to change all contract files to the new name.

BKTB Group, Inc. dba MC Austin hereby agrees to perform all duties and obligations to be performed by Vendor under Contract DIR-TSO-3992 to the same extent as if it had been an original party thereto.

BKTB Group, Inc. dba MC Austin also represents that it is not currently delinquent in the payment of any franchise tax owed the State of Texas and is not ineligible to receive payment under §231.006 of the Texas Family Code and acknowledges the Contract may be terminated and payment withheld if this certification is inaccurate.

BKTB Group, Inc. dba MC Austin hereby represents it is authorized to do business in the State of Texas and is in good standing with the Comptroller of Public Accounts.
