This Amendment Number 1 to **Contract** Number **DIR-TSO-4053** ("**Contract**") is between the Department of Information Resources ("DIR") and JHC Technology, Inc. formerly DoubleHorn, LLC ("**Vendor**"). DIR and Vendor agree to modify the terms and conditions of the **Contract** as follows:
