Electronic End User License Agreement

NOTICE TO USER: THIS IS A LEGALLY BINDING CONTRACTUAL AGREEMENT BETWEEN YOU ("Customer") AND DYNAMIS INCORPORATED REGARDING USE OF THE CoBRA SOFTWARE. BY INDICATING YOUR ACCEPTANCE BELOW, YOU ACCEPT ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE AGREEMENT, CLICK ON THE "CANCEL" BUTTON AND/OR DO NOT INSTALL THE SOFTWARE. YOU AGREE THAT YOUR USE OF THE SOFTWARE ACKNOWLEDGES THAT YOU HAVE READ THIS LICENSE, UNDERSTAND IT, AND AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF DIR CONTRACT NO. DIR-TSO-4170 AND THESE TERMS.

Dynamis Incorporated ("Dynamis") End User License Agreement (the "Agreement") accompanies CoBRA software and related explanatory CoBRA written materials (the CoBRA software and documentation are referred to herein as "Software"). The term "Software" shall also include any upgrades, modified versions, updates, additions, and copies of the Software licensed to you by DYNAMIS. DYNAMIS grants to you a nonexclusive license to use the Software and Documentation in the manner set forth below, provided that you agree to the following:

1. License Grant. Subject to your compliance with the terms of DIR Contract No. DIR-TSO-4170 and this Agreement, you may--

1.1. Use the Software over the Web on one or more computers in your network. This license for the Software may not be shared, used concurrently, or accessed and used by, another User.

2. Intellectual Property Ownership, Copyright and Trademark Protection. The Software (including but not limited to, any images, photographs, animations, video, audio, music, and text incorporated into the Software) and the copyright thereto are owned solely by DYNAMIS. Its structure, organization and code are the valuable trade secrets of DYNAMIS. The Software is protected by United States Copyright Law and International Treaty provisions. You must treat the Software just as you would any other copyrighted material, such as a book. You may not copy or electronically duplicate the Software, except as set forth in this Agreement. You agree not to modify, adapt or translate the Software. You also agree not to reverse engineer, decompile, disassemble or otherwise attempt to discover the source code of the Software. DYNAMIS trademarks shall be used only with your use of the Software and only as such mark is depicted and presented within the Software. No modifications,

adaptations, or other changes to the DYNAMIS trademarks are permitted. This Agreement does not grant you any copyright, patent, trademark, trade secret, or other intellectual property rights.

3. Transfer. You may not transfer, rent, lease, sublicense or lend the Software or Documentation.

4. Warranty. THE SOFTWARE AND DOCUMENTATION IS PROVIDED "AS IS" AND DYNAMIS MAKES NO REPRESENTATION AND GIVES NO WARRANTY AS TO ITS USE OR PERFORMANCE. EXCEPT FOR ANY WARRANTY, CONDITION, REPRESENTATION OR TERM THE EXTENT TO WHICH CANNOT BE EXCLUDED OR LIMITED BY APPLICABLE LAW. DYNAMIS AND ITS PARTNERS MAKE NO WARRANTY, CONDITION, REPRESENTATION, OR TERM (EXPRESSED OR IMPLIED, WHETHER BY STATUTE, COMMON LAW, CUSTOM, USAGE OR OTHERWISE) AS TO ANY MATTER INCLUDING, WITHOUT LIMITATION, NON-INFRINGEMENT OF THIRD-PARTY RIGHTS, MERCHANTABILITY, SATISFACTORY QUALITY, INTEGRATION, DATA PROTECTION, SYSTEM UP-TIME, OR APPLICABILITY FOR A PARTICULAR PURPOSE. DYNAMIS MAKES NO REPRESENTATION AND GIVES NO WARRANTY FOR THE OPERATIONAL OR PERSONAL DATA STORED IN THE SYSTEM. DESPITE BEST EFFORTS BY DYNAMIS TO PROTECT THE SOFTWARE AND DATA, THE LICENSE HOLDER IS NOTIFIED THAT POTENTIAL CORRUPTION OR DISCLOSURE OF THE SOFTWARE AND ALL DATA STORED IN THE SYSTEM IS VULNERABLE TO UNLAWFUL ATTACK AND EXPOSURE. YOU ACKNOWLEDGE AND AGREE THAT DYNAMIS AND ITS COLLABORATORS, SUPPLIERS AND LICENSORS, AND THEIR OFFICERS, DIRECTORS, EMPLOYEES AND AGENTS, SHALL HAVE NO LIABILITY TO YOU FOR ANY LOSSES SUFFERED, RESULTING FROM OR ARISING IN CONNECTION WITH UNLAWFUL AND UNAPPROVED ACCESS TO THE SOFTWARE AND OPERATIONAL DATA. YOU ASSUME ALL FAULTS, AND THE ENTIRE RISK AS TO PERFORMANCE AND RESPONSIBILITY FOR SELECTING THE SOFTWARE TO ACHIEVE YOUR INTENDED RESULTS, AND FOR THE INSTALLATION OF, USE OF, AND RESULTS OBTAINED FROM THE SOFTWARE. 6. Export Restrictions. If any part of this Agreement is found void or unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms. THIS USE LICENSE GRANTED BY THIS AGREEMENT SHALL AUTOMATICALLY TERMINATE UPON A FAILURE BY YOU TO COMPLY WITH ANY THE TERMS OF THIS AGREEMENT. This Agreement may only be modified in writing signed by an authorized officer of DYNAMIS and customer.
