Summary

The Department of Information Resources (DIR) is pleased to announce a bulk purchase of CA Technology products and related services. With the passage and of S.B. 261 from the 85th legislative session, DIR may now contract for the bulk purchase of information technology commodity items intended for use by more than one state agency without being constrained by certain dollar limitations that may otherwise have precluded a bulk purchase.

DIR has concluded vendor negotiations and customers may now issue purchase orders. The time period for placing orders is from October 1, 2018 through October 31, 2018.

Instructions for ordering

All DIR eligible customer may participate in the CA Technologies bulk purchase initiative. There is no minimum order quantity under the bulk purchase. Regardless of the number of licenses or other products purchased, each customer will pay the same, discounted price for items including but not limited to CA Privileged Access Manager, CA Continuous Delivery, and CA Veracode and related services listed in the pricing section.

DIR customers should contact CA Technologies or authorized reseller to receive a customized quote at Bulk Purchase discount rates. Customers should mention DIR Bulk Purchase initiative in their request for quote. Contact information may be found on the DIR contract page for [DIR-TSO-3793](#).

Once ready to order, please include the DIR contract number (DIR-TSO-3793) on your purchase order (PO) as well as the following statement, “**DIR Bulk Purchase Initiative BP2019-10**” on the product line item description. Please submit your PO directly to CA, Inc. or any CA authorized reseller, and forward a copy of your PO to bulk.purchase@dir.texas.gov.

As a reminder, state agency purchases outside of DIR negotiated Bulk Purchase Agreements are required to follow thresholds outlined in TGC 2157.
